Federal law does not allow for charitable donations through payroll deduction (CFC or any other payroll deduction program) to be done pre-tax. Donors who are eligible to itemize charitable contributions on income tax returns may include contributions made through the CFC.

Federal employees who are generally responsible for distributing campaign materials, such as Charity Lists and pledge forms, within their agency or unit/division. Key workers may also collect pledge forms and cash/check/money order donations from contributors, and transmit these items back to either the agency coordinator, a loaned executive (LE) or the PCFO.

The Federal Election Campaign Act Amendments of 1974 (FECA) form the basis of current federal campaign finance law. FECA's main provisions include limits on contributions to federal candidates and political parties, a system for disclosure and voluntary public financing for presidential candidates. FECA originally tried to impose mandatory spending limits on congressional candidates as well as on independent spending, but the US Supreme Court held these spending limits to be unconstitutional ...
